Renewal Terms	You will be notified of your fixed price contract expiration 45 days prior to the end of your contract with CleanSky. If you have not provided CleanSky affirmative consent for a new fixed price offer, you will be moved to a Variable Month-to-Month Price Plan - The monthly variable price plan may fluctuate up or down and may be higher than the Utility's rate at any point in time.
